### **OLD BUSINESS:**

- A. **Rule Update: Sleeping in Cars** Sue Harris, **made a motion**, seconded by Dee Doyle, **to create a new rule** Effective October 15, 2024, for anyone found sleeping in cars or tents, on BCC property will be fined at a new fine schedule at: \$50/day during the first week (first 7 days) the offense occurred and will be increased at \$100/day if the occurrence continues into a second week (second 7 days). Any additional weeks of the offence, the fee will be raised an additional \$100/day for each additional week (example: \$200/day for a third week, and so on). The motion passed with 6 yes votes, and 1 absent vote.
- B. Discussion: AMS Contract Updates Sharon provided an overview of the edits needed on the AMS Contract proposal. The Board sited some additional edits needed. The edited files were recorded by the Secretary and will be emailed to Sharon to send to AMS for final review. Sue Harris, made a motion, seconded by Jeanne Dalton, to accept the AMS contract and Exhibit A as written with the Board recommended edits and the BCC attorney's edits to be forwarded to AMS for final review. The motion passed with 6 yes votes, and 1 absent vote.
